- net operating surplus of \$27,545 compared to a budgeted surplus of \$16,189 excluding the Ministry Support Fund.
- Expenditure is \$10,000 below budget mainly due to lower than forecasted expenses in the area of Admin & Management.
- Cash flow forecast as in paragraph 4.2 on page 7.
- Debtors note: MITT has been paying \$1,000 per month since September, 2019.
- KPMG will be starting the Annual Financial Review from early May.
