- (c) Each nomination shall be accompanied by a short written statement by the nominator detailing the skills and experience that the nominee would bring to the work of the Standing Committee.
- (d) The nominee must indicate his or her agreement to nomination on the nomination paper being made.

4. TERM OF OFFICE

The members of the Standing Committee so elected shall remain in office until the commencement of Synod 2019.

THE MISCELLANEOUS STATUTES AMENDMENT BILL 2017

The Synod of the Diocese of Waikato and Taranaki enacts as follows –

1. TITLE

This Statute is The Miscellaneous Statutes Amendment Statute 2017.

2. PURPOSE

The purpose of this Statute is to make minor amendments to various Statutes, to clarify or amend provisions, or to correct errors.

3. COMMENCEMENT

Clauses 4(1) and 4(2) of this Statute shall come into force at the close of the last session of Synod in 2018. The remaining clauses of this Statute shall come into force at the close of the Synod at which it is enacted.

4. THE PARISHES STATUTE 2009

- (1) Clauses 10 (2) and 10 (3) are amended by deleting the word "annually" and replacing it with the words "at the annual general meeting prior to the first session of each Synod."
- (2) Clause 10 (6) is amended by deleting the words "at an annual or special general meeting each year" and replacing with the words "at the annual general meeting prior to the first session of each Synod."
- (3) Clause 10 (8) is amended by deleting the words "Standing Committee in consultation with the relevant Archdeacon," and replacing them with the word "Bishops".
- (4) Clause 30 is amended by deleting the words "recognised by the General Synod/te Hīnota Whānui".
- (5) Clause 30 (2) (b) is amended by deleting the word "does" and replacing it with the word "must".

5. THE ARCHDEACONRY STATUTE 2006

- (1) The Schedule to the Archdeaconry Statute 2006 is amended by deleting the words "for a period of five years".
- (2) The Schedule to the Archdeaconry Statute 2006 is further amended by adding, after the words "as they exist from time to time" (or alternatively) have stipulated the task(s) for which she/he shall be responsible".

6. THE WAIKATO AND TARANAKI DIOCESAN STATUTE OF SYNOD 2014

Clause 6 (1) is amended by adding an additional paragraph "(o) Licensed Lay ministers who, pursuant to a contract of employment with the Bishops, are appointed by them as lay leaders of a district or districts."

7. THE WAIKATO DIOCESAN STATUTE OF PASTORS 1993

A new clause 16 is added as follows:-

"<u>REGULATIONS</u> – The Standing Committee of the Diocese may make regulations under this Statute for any administrative purpose at any ordinary or special meeting."

Explanation

At our Synod of 2016, the Diocese voted to look to find ways to increase social and affordable housing in this Diocese and proactively engage in initiative to achieve this.

The trend for Selwyn St Andrew's in Cambridge appears to be one of significantly reducing affordable rental units and increasing the number of Occupation Right Agreement (ORA) units, thereby catering less for people of varying means.

Like many communities, Cambridge has been experiencing rapid increase in house prices. Consequently rents have increased

markedly. Houses are sold to make profit and often a sitting tenant is given notice to leave.

The Cambridge Committee of Social Services has become increasingly concerned, especially for the elderly. In one instance last year, an older person had to move four times within twelve months due to their rental being sold. The happy ending was that Selwyn St. Andrew's was able to offer them a rental unit so that they now have some security of tenure. Finding affordable housing is exhausting for anyone, especially for the elderly.

Selwyn St Andrew's is adjacent to the Anglican Parish Church in Cambridge. The first units were originally built on church land and administered by the church but the village is now owned and managed by The Selwyn Foundation. Selwyn St Andrew's has 65 villas but only nine rental units left and as a person leaves the policy appears to be that the unit is refurbished and available for ORA only, with an entry and exit payment plus monthly costs. There is a waiting list for rentals. It is unknown how many rental units they will keep available. Within their new building all eleven apartments have been for sale as ORAs and all rest home rooms have an ensuite, thus incurring an extra charge of \$140 per week, not funded by government rest home payments.

As units cease to be available to rent, so there is less opportunity to provide affordable housing to those in need.

The Archbishop welcomed the Synod and shared greetings from The Right Reverend Dr. Helen-Anne Hartley and The Most Reverend David Moxon.

CONSTITUTION OF SYNOD (continuation)

The Synod Secretary, declared that, pursuant to Clause 14(2) of the Waikato and Taranaki Diocesan Statute 2014, with one Bishop, 50 Clergy and 66 Lay Synod Representatives present, there was a quorum for the continuation of the First Session of the Thirty-Ninth Synod.

11.05 am Motion from the President:

"That speaking rights be extended to Mrs Elizabeth Bang and Mrs Cathy Franzoi."

CARRIED

11.05 am The Chancellor reported that changes were being considered to the

Statutes concerning elections but that it was not proper to change the

process in the middle of an election.

11.06 am Election Candidates

The Reverend Jacqui Paterson, Canon Dr Bryan Bang and Judge Chris Harding having already been elected, a further election for a single representative for each house (clergy and lay) to General Synod was needed.

The Reverend Cheryl Anderson had withdrawn her nomination.

"That this Synod supports the decision of the Waikato Diocesan Trust Board to sell the Diocesan Camp site."

The Archbishop expressed the important place the Camp had had in the life of many in the diocese and appreciation of all those who had supported the camp over the years, as well as The Venerable Trevor Harrison and Mr Peter Maxwell for accepting the task of moving and seconding the motion.

He assured the Synod that, should a decision be made that meant the Camp brought in money, it was his personal view that the only debt this would be used to address would be the Camp's own. He suggested that a Synod would discuss how any remaining money would be used.

The Archbishop asked that the Standing Orders be suspended to allow the immediate answering of questions, where appropriate and this was allowed.

The Chancellor spoke about the roles of the Synod and the Trust Board. The Trust Board was the legal owner of the Camp. Its role was to act in the interest of the diocese of the whole. The Synod's role was to provide insight into what the diocese wanted to do. Both sides needed to listen to the work of the other.

The Archbishop confirmed that the Trust Board would be legally bound to consider any serious option proposed, even if Synod were to vote to sell the Camp.

The Venerable Trevor Harrison moved Motion No. 13 and spoke to the motion, suggesting the season for Diocesan camps was over and youth ministry could be addressed in other ways. The practical leadership and finances required were beyond current resources and that the due diligence done by the Trust Board supported this. Mr Peter Maxwell seconded the motion, commending Mrs Cathy Franzoi and her family for their work and acknowledging the place of camps in his own life. He pinpointed the presence of God, the leadership of the camps and the environment (rather than the actual location) as the key factors in their importance to him. He went over the financial situation of the camp.

Mrs Elizabeth Bang spoke on behalf of the Trust Board. She expressed appreciation of the staff. Mrs Bang spoke about the advisors the Trust Board had used in the due diligence process. She outlined various options that had been investigated and the eventual conclusion that selling was the only practical one.

12.14 pm Elections for General Synod

The sixth ballot for a lay representative to General Synod was taken,

Mr Allan Tanner having withdrawn his nomination. The Archbishop thanked Mr Tanner for his previous service and willingness to serve.

12.17 pm Motion No. 13 – Te Rau Aroha (ctd)

Canon Reverend Pat Scaife spoke in support of the motion, underlining, however, the need to provide a new model for youth work, regardless of whether it was at the camp or not.

Mrs Cathy Franzoi spoke against the motion, sharing the numbers of those who have had the opportunity to hear the gospel at the camp and pointing out that modern youth also enjoyed camping. She asked Synod to consider the value of the Camp to those attending and, if it were to be sold, asked that it be sold within the Christian community.

It was unclear whether this created a clear trust for it to be used for youth. The Archbishop said the past history with regard to tangata whenua would be looked into.

The amendment was passed.

1.45 pm After speakers had spoken both for and against and questions had been answered, the Archbishop asked for a straw vote on the motion.

The discussion was adjourned.

1.49 pm The Chancellor took the Chair.

Motion No. 14: Shared Episcopacy

1. **TITLE**

This Statute is the Shared Diocesan Episcopacy Statute Amendment Statute 2017

2. PURPOSE

The purpose of this Statute is to add a clause to the Shared Diocesan Episcopacy Statute 2007 to clarify the position when a Bishop is absent from his or her Bishopric or when there is a vacancy in one of the Bishoprics.

3. **COMMENCEMENT**

This Statute shall come into force at the close of the session of the Synod at which it is enacted.

4. **NEW CLAUSE**

This Statute amends clause 5 of the Shared Diocesan Episcopacy Statute 2007 by adding to it a new sub-clause as follows:

(4) Notwithstanding the foregoing, during the absence of a Bishop from New Zealand or during an interregnum the other Bishop shall be the sole Diocesan Bishop as well as the Bishop of each Bishopric."

Motion: "That the Title, Purpose and Commencement be set aside for later consideration and the new clause and addition of sub-clause (4) be considered in detail."
