9.53am: Archbishop Philip permitted Florence to speak beyond 5 minutes. The Rev'd Florence Chambers continued.

9.56am: Archbishop Philip seconded, reserved right.

- 9.56am: The Rev'd Canon Pat Scaife went to first camp 60 years ago
  - Does this signal the end of Te Rau Aroha
  - What is the idea for the future
- 9.57am: The Rev'd Judy Clark camp report impressed and disturbed the most of all reports
  - Disappointed by managers comments re complaint
  - Mr Rodney Franzoi and his wife, Cathy, need back up/ supervision
- 10.00am: Archbishop Philip a report is a statement of position
  - Current Diocese Manager has made a number of attempts to address issue raised
  - Response to The Rev'd Canon Pat Scaife's concern no decision will be taken about 3 properties without Synod's approval even though this is not necessary
  - There will be no "backroom" deals
  - Need to recognise that all work needs to be done beforehand, is properly investigated
- 10.04am: The Rev'd Terry Ellis surprised that annual balance sheet not available
  - What is the \$300K deficit
  - How is that impacting on Diocese finance
- 10.06am: Archbishop Philip debt incurred and authorisation for this debt fell between two bodies, the owner and Standing Committee.
  - Lack of clarity of who gave authorisation

- Debt is on building. Actual >>anticipated
- That debt is incurring more debt
- Need proper research an these matters which is happening
- 10.08am: Mr Peter Maxwell support The Rev'd Florence Chambers' motion
  - Need management and leadership
  - Good management, but lacks leadership
  - Need oversight
  - Shouldn't consider in conjunction with Charlotte Brown house/ Victoria Street
- 10.11am: Archbishop Philip that is the focus of the investigation, each asset will be considered separately
  - Mission and Ministry must be a consideration
- 10.12am: The Rev'd Florence Chambers reply thanks given
- 10.13am: Archbishop Philip puts motion, CARRIED.
