Pat raised the question of statues being removed. ++P referenced Tiki Raumati and his strong view that the hatchments should stay in the Taranaki Cathedral as they reminded us of the history we need to own and acknowledge and Banksie's comments about the fallen statue in Bristol.

6. Matters Arising

- 6.6 Property Lease Work ongoing Elizabeth Bang reported that the lease should have been signed by now and this is being chased up by the lawyer.
- 6.7 Renewal and Review of TML Management Services Agreement Canon Gerald Bailey has discussed the Trustees' concerns about liability with Norris Ward McKinnon. A response was due by the time the Combined Diocesan Trusts Boards met last week. Elizabeth Bang reported that three options were provided. Trustees believed that the liability should be struck out.
- Strategic Planning Day: A small group of Senior Staff have been working on a strategic plan for the Diocese going forward and a webinar will be held shortly.
 Strategic Planning Day for Standing Committee, Bishop's Staff Team and Trustees would be held after that and the proposal, as reported by Simon Cayley, is that Chris Clarke would facilitate this day.
- 8.6 Delegation of Investment Strategy: Covered in Simon Cayley's report where he reported "Further to discussions at the April meeting The Episcopal Budget Advisory group have also reviewed the proposed strategy and have asked the Trust Boards to hold off agreeing to it until TEBAG has had a chance to meet with Trust Investment Management and discuss the strategy further. TEBAG do not think the proposed strategy offers the best outcomes for the episcopal endowment."

7. Finance:

• 7.1 Standing Committee: Robin Brockie referenced the report supplied: Standing Committee travelling well on budget at present. Acknowledged work being done by Anne Edwards and TML on assessing the landscape going forward and liaising with Finance and Audit, Diocesan Manager and himself. Audited statements for end of financial year have been worked on by KPMG and work is now complete and we should have those shortly and to date no problems have been flagged. Archbishop Philip reported that freewill offerings have held up well across most parishes. Any great decrease in income for parishes is in those that have Op Shops and cattle schemes. Overall across all parishes there is a 31% decrease in income.

This approval notes the cost of moving the building is \$240,323.17c, that the funds are in hand and the Vicarage will be fully redeveloped as a centre for hospitality and learning."
